On 22 December 2020, Sint Maarten and the Netherlands signed a mutual settlement for implementation of the Package of National Measures for Sint Maarten. The confirmation of this settlement has cleared the way for the realisation of a whole raft of reforms and investments aimed at enhancing the country's economic and social resilience. The economy of Sint Maarten must be improved in terms of sustainable economic growth and earning capacity. Good governance, solid government finances and social cohesion are vital contributing factors. The result will be an economy and society that is also more resilient in the face of crises - the COVID-19 pandemic may be exceptional, but has clearly revealed the underlying weaknesses and the necessity for improving resilience - with new opportunities for citizens and businesses.

The Package of National Measures includes measures in the following areas: financial management; costs and effectiveness of the public sector; taxation; the financial sector, the economy; healthcare; education and reinforcing the rule of law. Over the past few weeks, agreements have been reached on the first steps to be taken by Sint Maarten, often with assistance from the Netherlands. These steps are reflected in this Implementation Agenda.

The necessity for reforms is considerable; the level of ambition is high and the challenges are complex. This makes it vital to select a pathway that is not only ambitious but also realistic. In drawing up this Implementation Agenda, this was therefore the starting point. Moreover, it is of key importance that processes be implemented with due caution, that respect for the rule of law be guaranteed and that all the measures be harmonised regionally. A focus has been identified, priorities set and the actions to be taken have been determined as specifically as possible. Against that background, the Agenda forms the basis for the actions to be taken over the coming months, in line with the local context. The step-by-step approach will be clearly phased, and the conditions to be imposed will be formulated within the frameworks of the Package of National Measures.

The Implementation Agenda is a binding document. Both Sint Maarten and the Netherlands have committed to taking the steps agreed upon, and progress will be monitored. If it emerges that the agreed milestones are not achieved, possible solutions will be sought, for example in the form of additional assistance from the Netherlands.

The Implementation Agenda is a living document. Each step to be taken over the coming period will lead to further steps in the future. With that in mind, the Agenda will be regularly updated and as it moves forward will become more concrete. Initially this will take place on a quarterly basis, in line with the rhythm of the budget cycle for Sint Maarten and the Netherlands. It will also reflect decision making within the Council of Ministers for the Kingdom of the Netherlands in respect of additional blocks of budgetary support and other liquidity support, and necessary and complementary investments.

As already pointed out, the reforms agreed within the National Package of Measures are far reaching. The responsible implementation of that National Package of Measures, with the necessary care to bring about the intended goals, is a shared responsibility. This document is an important step towards fulfilling that responsibility.
